

AUSTRALIAN PROPERTY INSTITUTE CONSTRUCTION SAFETY AWARENESS TRAINING

BLUE CARD QUALIFICATION

It is a requirement under the WA Occupation Safety and Health Act that specified personnel on building construction sites must have appropriate approved OSH training and hold a Blue Card, valid for 3 years, verifying that training has been completed.

Unaccompanied valuers and other property professionals who enter residential and non-residential building construction sites should hold a Blue Card. In some circumstances building supervisors may refuse entry unless a Blue Card is held.

API WA has engaged the services of Training Course Professionals to conduct specific Blue Card training for valuers. Accredited course leaders will provide all resources and issue the Blue Card to registrants. To maximise the training benefits, each course is limited to 25 participants.

Who should attend?

Employers, line managers, section leaders, risk managers and all employees who enter building construction sites accompanied or unaccompanied.

Venue
